#### Homegrown Analysis Account \*\*

Monthly service charge ..... Free  
Non-Main Street Bank ATM transaction ..... \$1.50  
A competitive earnings credit is applied to deposit balances in Analysis account to offset or reduce monthly fees.

#### Homegrown Premium Interest Checking\*\*

Interest-bearing account, must have a Homegrown Analysis Checking Account. No monthly service charge if daily minimum balance is >\$10,000. If balance falls below \$10,000, the monthly maintenance fee applies.  
Monthly service charge ..... \$500.00  
Non-Main Street Bank ATM transaction ..... 1.50

#### Homegrown Payroll Checking\*\*

Must have a Homegrown Analysis Checking Account. No minimum balance required.

#### Homegrown Money Market (must also have another existing MRB Account)\*\*
